# WHAT IS THIS PRODUCT?

This product is not subject to any fixed term.

#### **Objectives:**

The Fund aims to provide capital appreciation over the long term (at least 3 - 5 years) comprising both capital growth and income. The Fund has a global mandate and seeks to achieve its objective by investing principally in a portfolio of high quality equity securities with a market capitalisation of at least US\$1 billion or equivalent. The aim of the Fund is to actively invest in companies for compound returns through long-term capital appreciation. The Fund will typically hold 25-35 individual securities with larger holdings typically representing 10% of the Net Asset Value of the Fund at cost. The Fund may engage in transactions in financial derivative instruments ("FDIs") for the purposes of hedging and efficient portfolio management. The Fund may not be appropriate for investors who plan to withdraw their money within a short period of time. Shares can be bought, exchanged and sold back to the Fund on the "Dealing Day", daily, or the next business day, if not a Business Day. This class does not intend to pay a dividend. Instead, any income or gains will be reinvested and reflected in the value of your shares. The Fund is actively managed. This means the Investment Manager is taking investment decisions with the intention of achieving the Fund's investment objective; this may include decisions regarding asset selection, regional allocation, sector views and overall level of exposure to the market. The Investment Manager is not in any way constrained by a benchmark in their portfolio positioning. The MSCI World USD Index is the benchmark index against which the Fund's performance is compared. This is an industry standard index and one of the leading representations of the Global Equities Market. It is easily accessible and provides a fair reflection of the Investment Manager's investment universe and a good relative measure to assess performance outcomes.
